## OUTFITTER/HUNTER AGREEMENT

The purpose of this agreement is to set forth the terms under which the undersigned parties shall abide in regard to the provision of outfitting services.

The outfitter, **BackRhoads**, agrees to provide the following services:

1. Guaranteed access to private lands routinely used and or occupied by the game animal(s) sought. However, **BackRhoads** makes no guarantees, neither written nor implied, as to the quantity nor quality of game animals due to uncontrollable forces.
2. Transportation will be provided during the hunt, including to and from the field or hunt area. Transportation to and from the hunt site is not provided and is not included in the price of the hunt. Vehicles and ATV's are of above average quality to insure client safety and enjoyment. Equipment and mechanical failure is still a possibility, but will not significantly impact the time or quality of the hunt.
3. Meals, snacks, and beverages will be provided during the actual hunting days. No alcoholic beverages will be provided. You are welcome to bring your own; however, consumption of alcohol is prohibited during hunting hours.
4. Warm comfortable sleeping accommodations will be provided for the number of nights equal to the number of hunting days, plus one. (i.e. - A five day hunt includes 6 nights lodging.)
5. Game will be field-dressed and removed from the hunt area. Skinning is included. Caping, taxidermy, and processing of meat are not included, nor any charges associated with them, including shipping.
6. Landowner authorizations or permits will be provided for all elk hunts. The cost of the New \_\_\_\_\_ Dept. of Game and Fish big game license is included unless otherwise stated. Turkey, Pheasant and Quail license must be purchased by the hunter. The big game License will be purchased prior to client's arrival provided that the appropriate paperwork has been completed and returned to **BackRhoads** no later than two (2) weeks prior to the hunt starting date.
7. Failure to return paperwork or to provide balance of payment may be interpreted as cancellation of hunt and will result in forfeiture of any deposit.
8. Experienced guides with knowledge of the hunt area will be provided by the outfitter on a 2 hunter/1guide basis. Requests for specific guides will be taken into consideration, but no guarantees are made as to his/her availability; however, all **BackRhoads** guides are of the highest professional quality.
9. No addendum nor exception is legally binding unless listed on page two of this agreement and initialed by both parties.

Due to the nature of the hunting business and the limited ability to "resale", client herein acknowledges that the deposit becomes nonrefundable 150 days prior to the start date of hunt. to be paid 30 days prior to hunt. No tags will be purchased until account is paid in full.

Note: BackRhoads will consider crediting a portion of the deposit towards a future hunt (if available) provided cancellation notification is received 90 days prior to the hunt starting date.

Furthermore, client acknowledges personal and financial responsibility for meat processing, taxidermy, shipping, and any other charges not expressly set forth in this agreement.

In addition, the client agrees to obey all applicable game laws and ranch rules. The client also agrees to respect the knowledge and experience of his/her guide and the outfitter, which is the essence of the service provided.

Wounding of an animal may bring an end to the hunt. Client will be allowed to pursue only the wounded animal for the duration of the hunt. The outfitter will be the sole judge in determining the outcome in wounding/tracking situations.
